



## “Get Combo Voucher at CGV” Terms and Conditions

### 1. Program Scope

The program “Get free Combo voucher at CGV” applies at Ha Noi and Ho Chi Minh City for cardholders of all Citibank Credit Cards issued by Citibank in Vietnam.

### 2. Program Period

Program is to be applied from the August 20<sup>th</sup>, 2015 until August 19<sup>th</sup>, 2017 (both days inclusive) for CGV in Ha Noi and Ho Chi Minh only.

### 3. Eligible Product

All Citibank Credit cards (PremierMiles, Cash Back, Rewards, ACE Life) issued by Citibank.

### 4. Program Mechanics

Eligible customer will receive a CGV combo voucher to convert to CGV combo (including 2 soft drinks regular size and 1 large popcorn ) when using Citibank Credit Cards to undertake an Eligible Transaction (“ Combo Voucher”).

### 5. Eligible Customer

Existing Cardmember of Citi PremierMiles, Citi CashBack, Citi Rewards, Citi ACE Life issued by Citibank.



## **6. Eligible Transaction**

- Retail transactions made on Citi Credit Cards to purchase at least 2 movie tickets of Saturday show at any CGV counter during the Program period. Charge slip must contain the following information for verification: Card Issuing Bank Name, Card Holder Name, Merchant Name, and Total Transaction Amount;

- Citibank reserves the rights to reject offering the Combo Voucher if the customer refuses to provide sufficient information.
- Each customer will receive maximum one (01) Combo Voucher per eligible transaction.

## **7. Redemption of Combo**

- Upon successful booking of the tickets, Eligible customer will receive a Combo Voucher.
- The customer has to present the combo voucher to the F&B counter to get the free Combo.
- Each Combo Voucher is redeemable for one Combo and only valid within the same Saturday day that customer purchases movie ticket.

## **8. Other Terms and Conditions:**
